<u>Alternative #2:</u> Under this alternative all existing bridge and approach guide rail will be removed and replaced in order to fully meet current standards. The estimated cost for this alternative is \$98,000.00. Upon review and discussion of the proposed alternatives, motion was made by D. Stocklosa to bid the job out using Alternative #2, 2<sup>nd</sup> by J. Bailey.
